Clarification 11-02

Update of Revenue & Expense Guide Classification

Reason for this Clarification

Part I of the 11th Revised Edition of the USALI indicates where certain revenues and expenses should be classified in the narrative for each departmental schedule. To assist readers Part IV Revenue and Expense Guide lists many revenue and expense items along with the name of the account classification and department they are applicable to.

The Financial Management Committee ("FMC") has determined that certain Revenue and Expense Guide references are not consistent with the classification described in the Part I departmental narrative.

The FMC maintains that where an inconsistency exists between related parts of the USALI, the references in Part I (the Operating Statement) are taken to be correct.

This clarification identifies the known inconsistencies and provides revised guidance as to which account classification should be used in each instance.
